

#### **OUR MISSION**

Warriors & Quiet Waters Foundation guides post-9/11 combat veterans and their loved ones to thrive and find peace, meaning, and purpose through fly fishing and other inspirational activities in nature.

# A Letter from the CEO and Board Chair

Warriors & Quiet Waters (WQW) is exceptionally proud of the increased impact on the lives of post-9/11 combat veterans and their loved ones we achieved and the progress we made in charting a long-term path to an even greater impact on those we serve.

#### Some notable 2021 highlights include:

**EVALUATING OUR IMPACT.** In partnership with Syracuse University's Institute for Veterans and Military Families (IVMF), WQW completed our first full year of measuring our program impact using a completely redesigned evaluation model. By surveying our participants prior to each Fishing Experience (FX), immediately after each FX, and annually at year's end, we measured how well we achieved the participant outcomes we sought.

Our participants' response was exceptional, with 90 percent of our program participants responding to post-program surveys. Through a statistical analysis of the survey responses, IVMF identified the following impacts on participants following their participation in our programs:

- Significant improvements in our participants' sense of purpose, clarity about what a meaningful life is, a sense of belonging in community, ability to handle personal problems, having a good night's sleep, increase in the feelings of positive emotions, overall well-being, and hopefulness.
- Time spent in nature became a space where participants were more likely to think clearly, and generally feel better.
- Participants had decreased feelings of nervousness and stress. They were less likely to report feeling angered
  with things outside their control, and they reported a reduction in negative emotions after their
  WQW participation.

**CONTINUED GROWTH AND INNOVATION.** We delivered 25 weeks of veteran and military family programming. That's 32 percent more programs than we've ever done in a single year, providing 217 participant experiences – 57 percent more participant experiences than any prior year. We also launched two new, highly-successful program models – our Family and Conservation Fishing Experiences. The Family FX creates opportunities for families to work on outcomes such as improved family communication, problem-solving, and relationships. In addition to the outcomes fly fishing provides, the Conservation FX also gives our Alumni opportunities to find meaning, achievement, and camaraderie through collective service.

A LONG-TERM COMMITMENT TO INCREASED IMPACT ON POST-9/11 VETERANS AND THEIR FAMILIES. The Board of Directors committed to a long-term vision for the future of our veteran programming, and the staff quickly got to work implementing that vision. This year-long effort, which we've dubbed "Program Transformation," will bring significant added value to our programming in terms of the impact while retaining the key elements of our programming and the participant experience that have served us so well since our inaugural FX in 2007. We look forward to sharing this work with you in 2022.

The committed support of our donors, corporate sponsors, foundation partners, and volunteers made this all possible. That commitment and generosity enabled WQW to raise the funds required to meet our yearly operating expenses.

We're proud of these accomplishments and hope that you are too. Going forward, WQW is laser-focused on increasing our impact on the lives of post-9/11 combat veterans and their loved ones in 2022 and beyond.



#### **2021 FINANCIALS**

Warriors & Quiet Waters Foundation (WQW) employs our donors' resources with discipline and strict stewardship to achieve maximum positive impact upon our nation's post-9/11 combat veterans and their loved ones. With a keen eye to efficiency and thoughtful use of existing resources, 2021 donations ensured our ability to expand programming while preparing for the future. This would not have been possible without the support of WQW's generous donors.

The graphs on the right display the sources of income and associated expenses for 2021. Of note:

- Of the \$180,000 in endowment contributions, \$146,000 is comprised of deferred gift annuities, all of which are deposited into a holding account until released by the donor after a minimum of five years. Upon release, these funds will be deposited into the program-focused Henry H. and Marion S. Uihlein Warrior Endowment.
- The small deficit of \$59,000 was withdrawn from one of WQW's two endowments to cover maintenance of Quiet Waters Ranch.

Because of the stalwart generosity of WQW supporters, WQW is actively preparing to increase impact on those we serve – doing more, for more.




