This document is subject to change as new programs are approved, deadlines shift, and organizational guidance documents are released and will continue to be updated and distributed as needed. It is intended for use as a tool for future planning and to promote partnership between resource providers and state, local, territorial, and tribal entities. For the most up to date and accurate programmatic information, interested parties should visit each individual organization's website or work directly with the relevant entity.

#### R1. USDA/RD - Distance Learning and Telemedicine Grants

Resource Type: Grant

Agency/Organization: (USDA) Department of Agriculture – Rural Development

Funding Type: N/A

Program Description: The DLT Program provides financial assistance to enable and improve distance learning and telemedicine services in rural areas. DLT grant funds support the use of telecommunications-enabled information, audio and video equipment, and related advanced technologies by students, teachers, medical professionals, and rural residents. These grants are intended to increase rural access to education, training, and health care resources that are otherwise unavailable or limited in scope. Applicants are encouraged to identify specific ways in which these funds can be used to prevent, prepare for, and respond to coronavirus. Grant funds may be used for the acquisition of:

Instructional programming that is a capital asset

- Technical assistance and instruction for using eligible equipment
- Eligible capital assets such as:
- Broadband transmission facilities
- Audio, video and interactive video equipment
- Terminal and data terminal equipment
- Computer hardware, network components and software
- Inside wiring and similar infrastructure that further DLT services

Total Program Funding: \$25,000,000

Max Award: \$1,000,000

Eligibility and Description/Use: Independent school districts, Private institutions of higher education, County governments, Nonprofits that do not have a 501(c)(3) status with the IRS – other than institutions of higher education, City or township governments, State governments, For profit organizations other than small businesses, Native American tribal governments (Federally recognized), Public housing authorities/Indian housing authorities, Special district governments, Small businesses, Nonprofits having a 501(c)(3) status with the IRS – other than institutions of higher education, Native American tribal organizations (other than Federally recognized tribal governments).

Application Deadline: July 13, 2020

Application Process: All applicants should carefully review and prepare their applications according to instructions in the FY 2020 DLT Grant Program Application Guide (Application Guide) and program resources. The Application Guide can be found in the link below. Expenses incurred in developing applications will be at the applicant's own risk.

Cost Share: Yes – 15% minimum

#### R2. USDA/RD - Community Facilities Direct Loan and Grant Program

Resource Type: Grant and Loan

Agency/Organization: (USDA) Department of Agriculture - Rural Development

Funding Type: Annual

*Program Description:* To construct, enlarge, extend, or otherwise improve community facilities providing essential services to rural residents. Community facilities include (but are not limited to) those providing or supporting overall community development - such as hospitals, fire protection, public safety, libraries, education facilities, childcare facilities, food recovery and distribution centers, assisted living facilities, group homes,

mental health clinics, and shelters. Projects comprise community, social, health care, education, cultural, transportation, industrial park sites, fire and rescue services; access ways, and utility extensions. Funds may also be used to acquire land needed for a facility, to pay necessary professional fees, or to purchase equipment required for a facility's operation. All facilities financed in whole or in part with RHS funds shall be for public use.

Total Program Funding: \$32 Million (with some restrictions)

Max Award: Based on repayment ability

Eligibility Description/Use: Eligible borrowers include: Public bodies, Community-based non-profit corporations, federally recognized, Tribes. Rural areas including cities, villages, townships and towns including Federally Recognized Tribal Lands with no more than 20,000 residents according to the latest U.S. Census Data are eligible for this program.

Application Deadline: Open application window

Application Process: Typically, 60 -120 days from submission of complete application; contact your local RD office for process information. R3. FCC – Universal Service Administrative Company - Rural Health Care Program (Broadband Connectivity)

Resource Type: Payment Deferment and Forbearance

Agency/Organization: (USAC) Universal Service Administrative Company

Funding Type: Non-supplemental

Program Description: As an independent not-for-profit designated by the FCC, USAC administers the Universal Service Fund, almost \$10 billion available annually to the companies and institutions that make universal service possible. With the guidance of policy created by the FCC, we collect and deliver funding through four programs focused on places where broadband and connectivity needs are critical. Universal service programs build out the country's network infrastructure and serve our schools, libraries, rural healthcare clinics, and people in rural, underserved, and difficult-to-reach areas. The programs are as follows: Schools and Libraries; Rural Health Care; Lifeline; and High Cost. The Rural Health Care (RHC) Program supports health care facilities in bringing world class medical care to rural areas through increased connectivity. It supports

reduced rates for broadband and telecom services. There are two subprograms in the RHC Program:

- Healthcare Connect Fund (HCF) Program: Flat 65% discount on eligible expenses including broadband services, network equipment, etc.
- Telecommunications (Telecom) Program: Discount Rate for voice and other telecommunications services determined using the urban/rural differential.

Eligible applicants may apply for both programs.

Application Process: 1. Determine your eligibility.

- 2. Develop evaluation criteria and request services.

- 6. Work with service provider to invoice USAC.

# R4. FCC – Universal Service Administrative Company - Rural Health Care Telecommunications Program

Resource Type: Payment Deferment and Forbearance

Agency/Organization: (USAC) Universal Service Administrative Company

Funding Type: Non-supplemental

*Program Description:* The Universal Service Administrative Company (USAC) Rural Health Care (RHC) Telecommunications Program provides assistance to healthcare providers for eligible expenses related to broadband connectivity based on the urban-rural price difference in an area.

Total Program Funding: \$604,759,306

Max Award: N/A

Eligibility and Description/Use: Rural public or nonprofit healthcare providers (HCPs) are eligible. Eligible entities include: Post-secondary educational institutions offering healthcare instruction; such as teaching hospitals or medical schools; Community health centers or health centers providing healthcare to migrants; Local health departments or agencies; Community mental health centers; Nonprofit hospitals; Rural health clinics; including mobile clinics; Dedicated emergency rooms of rural for-profit hospitals; Part-time eligible entities located in facilities that are ineligible; and Skilled nursing facilities.

#### R5. HHS/HRSA - Telehealth Focused Rural Health Research Center Program (93.155)

Resource Type: Cooperative Agreement

Agency/Organization: (USHHS) Department of Health and Human Services – (HRSA) Health Resources and Services Administration

*Program Description:* The TF RHRC Program provides support for two (2) four-year research centers with a concentration on telehealth (one with a focus on evidence and one with a focus on evaluation) specifically to provide infrastructure to support telehealth services researchers as they explore the complexities of telehealth issues.

R6. HHS/ACF - CARES Act: FY20 Family Violence Prevention & Services Program - Supplemental Funding for the National Domestic Violence Hotline

*Program Description:* This funding will provide flexibility in how agencies can prevent, prepare for, and respond to the COVID-19 public health emergency while addressing the evolving needs of domestic violence survivors and local domestic violence programs within their communities.

Application Process: The FVPSA Program is implementing a streamlined application process for all FVPSA formula grantees to receive CARES Act funding. All application documents need to be submitted through Grant Solutions within 30 days of the supplemental award release date which will be June 11, 2020. The project period for this supplemental funding to the National Domestic Violence Hotline is March 27, 2020 through September 30, 2020. Please direct any questions to the FVPSA Project Officer and OGM Grants Management Specialist assigned to your grant. CARES Act Reporting Instructions for the National Domestic Violence Hotline provides the required documents that need to be submitted to the FVPSA Program via Grant Solutions for the supplemental funding; and CARES Act Use of Funding for the National Domestic Violence Hotline lists allowable activities to support your COVID-19 efforts in preventing, preparing and responding to COVID-19 to support victims of family violence, domestic violence, and dating violence.

#### R7. Foundation for Rural Service - Community Grants Program

Funding Type: Non-supplemental

Program Description: As part of its ongoing commitment to rural communities across the country, FRS offers aid for communities served by NTCA's rural broadband members through its annual Community Grants Program. These grants are designed to provide support to a variety of local efforts to build and sustain a high quality of life in rural America. Winning projects help rural communities across the United States overcome an array of challenges, including access to technology, improving educational offerings, and providing telemedicine and first responder services to rural areas. Each year, the Foundation for Rural Service (FRS) gives back to rural communities through the grant program. In 2018, FRS awarded 12 grants for a total of nearly \$50,000. Applications for these grants are accepted each spring ranging from \$250 to \$5,000. The grants awarded each December support a variety of projects concentrated in four major categories:

#### R9. FCC – CARES Act: COVID-19 Telehealth Program

Resource Type: Grant

Agency/Organization: (FCC) Federal Communications Commission

Funding Type: Supplemental

Program Description: The COVID-19 Telehealth Program will provide \$200 million in funding, appropriated by Congress as part of the Coronavirus Aid, Relief, and Economic Security (CARES) Act, to help eligible health care providers provide connected care services to patients at their homes or mobile locations in response to the novel Coronavirus 2019 disease (COVID-19) pandemic. The Program will provide immediate support to eligible health care providers responding to the COVID-19 pandemic by fully funding their telecommunications services, information services, and connected devices necessary to provide critical connected care services until the program's funds have been expended or the COVID-19 pandemic has ended. The COVID-19 Telehealth program is not a grant program. Funding recipients will be reimbursed for eligible services and devices that they have paid for and received. The FCC started accepting applications for this program on April 13, 2020.

Total Program Funding: \$200,000,000

*Max Award:* \$1,000,000

Eligibility and Description/Use: Healthcare Institution, Nonprofit, and Public Health Care Providers.

Application Deadline: Applications Accepted Continuously

Application Process: Funding decisions will be made on a rolling basis, and the FCC will continue to accept and review applications until the funding is exhausted or the current COVID-19 pandemic has ended.

*Program Description:* To improve student's academic achievement by increasing the capacity of States, local educational agencies, schools and local communities to:

- 1. Provide all students with access to a well-rounded education
- 2. Improve school conditions for student learning
- 3. Improve the use of technology in order to improve the academic achievement and digital literacy for all students.

This is one of several Department programs that provides funds that could be used to support broadband access. The allowability of costs is always situation and program specific. For that reason, if you decide to use funds under one of these programs for costs related to device or mobile hotspot access, you must be sure that the use of the funds is, under the specific circumstances of the expenditure and the program authority selected, reasonable and necessary for the purposes of that program, and does not violate other program requirements, such as supplement not supplant, if it applies to program. We also note that, while funds under one of these programs can be used on broadband access, the programs' purpose is not primarily focused on that issue. The use of SSAE Program funds for broadband infrastructure must be consistent with the definition of "minor remodeling" in 34 CFR Part 77. That definition of minor remodeling means "minor alterations in a previously completed building. The term also includes the extension of utility lines, such as water and electricity, from points beyond the confines of the space in which the minor remodeling is undertaken but within the confines of the previously completed building. The term does not include building construction, structural alterations to buildings, building maintenance, or repairs."

- Planning and implementing activities related to summer learning and supplemental afterschool programs, including providing classroom instruction or online learning during the summer months and addressing the needs of lowincome students, students with disabilities, English learners, migrant students, students experiencing homelessness, and children in foster care.
