As a precursor to you reading the document, allow me to repeat what I have stated so many times:

1. I take Covid seriously as a disease. It can be deadly. I was very sick with it, and ended up in the hospital. Some of my friends have died. I had it once. I don't want to have it again. I take it VERY seriously. I know what it could do to me. No one ever needs to tell me that Covid is serious. I know it is.
2. However, I do not appreciate the manipulation and hiding of statistics that

have been done by certain governmental entities and medical persons within government. This is deception.

3. In our Constitutional Republic, persons should not be cancelled by government, private businesses or Big Tech for giving dissenting opinions. (Yes, I am aware of the argument which says that the 1st Amendment applies only to government.)
4. I do not appreciate the severe anti-Constitutional, governmental overreach, including forcing, coercing, pressuring, or threatening people regarding getting the shot. The same applies to companies that force their employees to get the shot, or fire them – or threaten to fire them – if they do not.
5. Allow people to decide what they will put in their bodies. Those who desire the vaccine can get the shot. Those who do not want it should be left alone.
