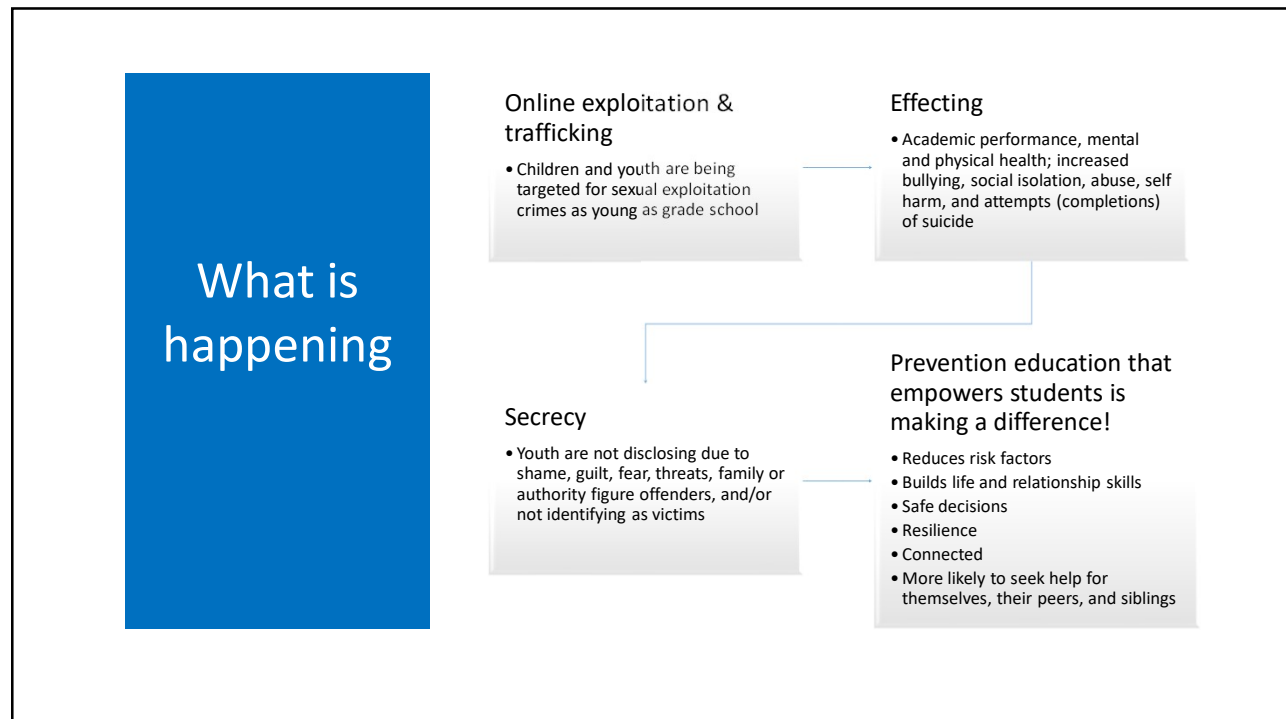

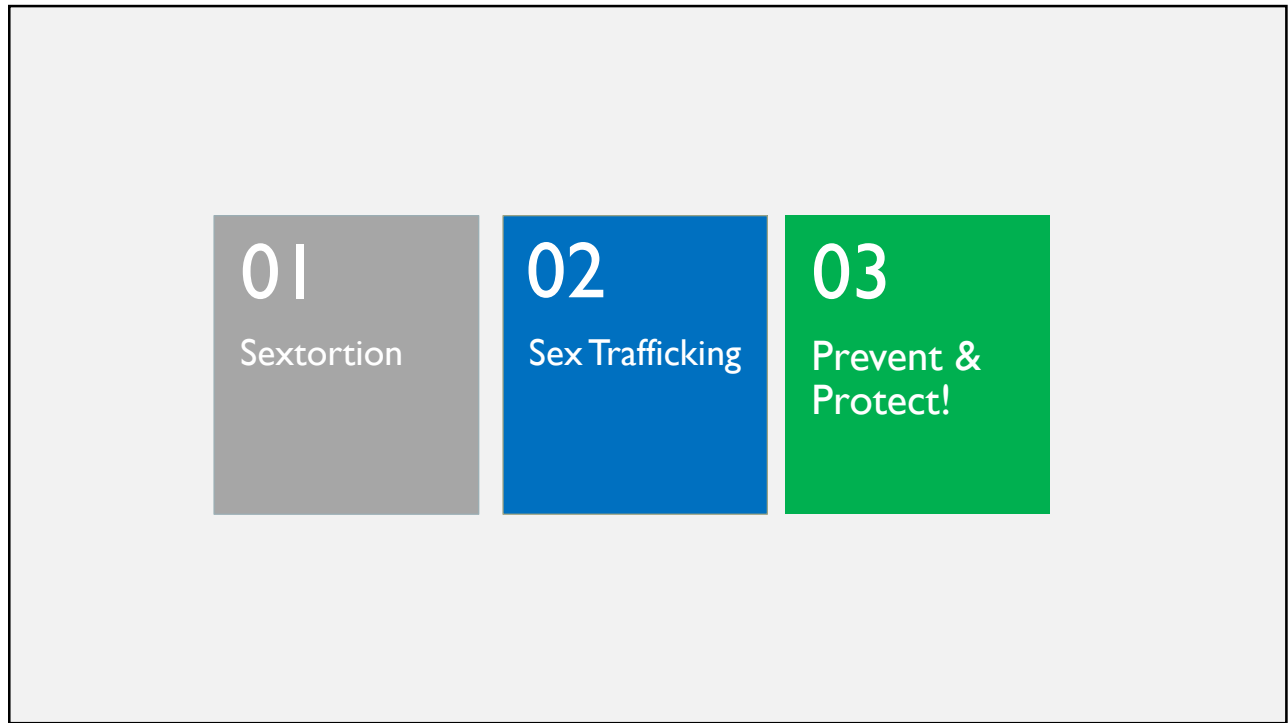

SEXTING

Sharing explicit content on a digital device

SEXTORTION

Soliciting and using a child's nude or explicit image to threaten exposure or physical harm if they do not:

Send more sexual content

Send money

Meet in person

Stay in an abusive relationship

- **Victims of sextortion** are all ages
all genders, communities, and economic status'

People who get and misuse photos & videos

- Peers, boy/girlfriends, people you know in real life
 - Authority figures or family members
- Friendships or romantic interests online
 - "Catfish" with a fake profile

The Impact of Victimization

- Feelings of hopelessness
- Fear
- Anxiety
- Depression
- Bullying
- 1 in 3 youth engaged in self harm, threatened or attempted suicide
- No age or gender differences in amount or severity of negative outcomes

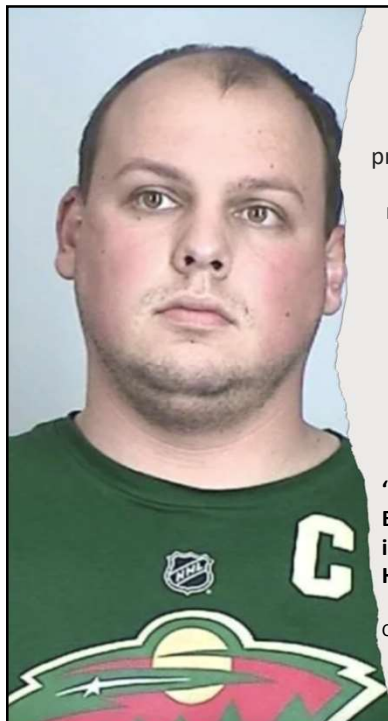

SECREC

- Threats of physical harm
- Threats to expose sexual content
- Feeling partly responsible, guilt, shame
- Fear of offender's retaliation
- Fear of getting in trouble

- Substitute teacher and paraprofessional in Eastern Carver County school district 112
- Used 2 fake social media personas
- 10 known child victims, some from the elementary school he worked in
- Solicited and threatened kids to send more nude and sexual images
- Investigation on his digital devices found child sexual abuse videos of victims as young as 2 years old

“Eagan Man Pleads Guilty in Teen Sextortion Case”

Star and Tribune Jan 14, 2016

- Fake social media profiles
- Builds online relationship
- Found victims names on high school sports rosters, scoreboards, newspaper
- 300 victims, 171 high school boys
- 3,000 pornographic images collected
- 1,000 images disseminated
- 1 victim assaulted, 2 victims die by suicide




JUVENILE SEX TRAFFICKING IS

To exploit a person **under age 18** by facilitating the **exchange** of something of value for any sex act

15

- Every County in MN
- 3rd highest rate of child (0 – 18 yrs) sexual exploitation crimes in the nation
- 12,000 persons trafficked any given day
- **2019 MDH MN Student Survey**
5,000+ students

Child sex abuse images & sex trafficking

- Recruitment “breaking in” filmed
- Juvenile sex trafficking ads on the internet
200/month x 3 on holidays
- Buyers
 - Hx of sex image addiction preceding child sex trafficking
 - Take photos & videos of sex assaults

Child sexual abuse material (CSAM)

- 2019 top searches in Pornhub were parent child incest up 108% and teens up 15%
- 78% of CSAM images depict children under 12
 - 63.4% were boys and girls under 8
- The more painful, loud, and physical damage caused in the recorded rape of children, the further access pedophiles get into CSAM trading networks
