Statistics: (Teens)

An estimated 55% of male and female teens have had sexual intercourse by age 18 and approximately 80% of teens used some form of contraception at first sex, according to a new report by the CDC's National Center for Health Statistics (NCHS).

Among the teenagers who are between 12 and 14 years old

1. About twelve percent of them are sexually active. 5% of teenagers aged 12 are sexually active. 10% of teenagers aged 13 are sexually active and 20% of teenagers aged 14 are sexually active. This piece of teenage sexuality statistics can be surprising one takes into account the fact that less than 50% of all teenagers between the age of 12 and 14 actually have gone on a date. The more surprising or discomforting reality is that the teenage sexuality statistics over several years have clearly indicated an upward trend.

An interesting reality derived from contemporary teenage sexuality statistics is that girls between the age of 15 and 19 are less likely to have sex, which is possibly because of the fear of becoming pregnant, getting infected with sexually transmitted diseases or HIV or simply because they are more informed and mature. But the bad news is that more girls between the age of 12 and 14 have become sexually active in recent years. In other words, chances of a girl losing virginity at the age of 12 to 14 is higher now than ever before, whereas it was 16 to 19 for a long time in the past.

3. More teenagers are opting for more than one sex partner today. 25% of those aged between 12 and 14 years old reported to be sexually active have sex with more than one person in a period of one year or two years.

4. Teenage couples that are of the same age have a 13% chance of indulging in sex. When one teenager is 2 years older, then that chance increases to 26%. If one of the partners is 3 years older, then that chance increases to 33% and if a young teenager (12-14) dates an old teenager (15-19), then the chance of indulging in sex goes up to 47%. In other words, almost half of all teenagers who date people four years older or more will have sex. This applies to all teenagers dating someone who may or may not be a teenager but is four or more years older. This reality is further emboldened by the fact that more than 10% of young teenagers date or get involved in a relationship with another teenager who is at least three years older.







• Even if a pregnancy doesn't go to full term or if you have an abortion, these cells still migrate into your bloodstream.



The Guttmacher Institute totals are actually the more accurate since the Institute conducts private research on abortion providers throughout the country and because not all states are required to report to the CDC. In fact, California and New York, where high numbers of abortions occur, are not included in CDC figures.

Primary nationwide abortion statistics for the United States are available from two sources privately from the Guttmacher Institute (AGI) and publicly from the Centers for Disease Control (CDC). Guttmacher's numbers, published every three years, come from direct surveys of all known and suspected abortion providers in the United States. The CDC numbers, published annually, are derived from actual counts of every abortion reported to state health departments. Unfortunately, California, Maryland, and New Hampshire do not publicly report abortion totals. As such, Guttmacher's abortion numbers are more complete, but they are approximations. Since only 59% of queried providers responded to Guttmacher's latest survey, health department data was used for an additional 19%. Abortion totals were estimated for the


- Based on available state-level data, approximately <u>890,000 abortions</u> took place in the United States in 2016—down from approximately <u>913,000 abortions</u> in 2015.
- In 2019, approximately 19% of U.S. pregnancies (excluding spontaneous miscarriages)
 ended in abortion.¹
- According to the <u>United Nations' 2013 report</u>, only nine countries in the world have a higher reported abortion rate than the United States. They are: Bulgaria, Cuba, Estonia, Georgia, Kazakhstan, Romania, Russia, Sweden, and Ukraine.*

*Though the UN lists China's official abortion rate at 19.2, China's actual abortion rate is likely much higher. According to <u>China's 2010 census</u>, there were approximately 310 million women of reproductive age in the country. An <u>estimated 13-23 million abortions</u> happen annually in China, resulting in an adjusted abortion rate of 41.9-74.2. The abortion rate is the number of abortions per 1,000 women aged 15-44.

- In 2017, the highest percentage of pregnancies were aborted in the District of Columbia (37%), New Jersey (32%), and New York (31%). The lowest percentage of pregnancies were aborted in Idaho (5%), South Dakota (4%), and Wyoming (2%). (AGI abortion data + CDC birth data).
- In 2018, approximately 31% of all pregnancies in New York City (excluding spontaneous miscarriages) ended in abortion (CDC).
- In 2019, unmarried women accounted for 86% of all abortions (CDC).
- Among married women, 4% of 2019 pregnancies (excluding spontaneous miscarriages) ended in abortion. Among unmarried women, 28% ended in abortion (CDC).
- Women in their 20s accounted for the majority of abortions in 2019 and had the highest abortion rates (CDC).
- Adolescents under 15 years obtained 0.2% of all 2019 abortions; women aged 15–19 years accounted for 8.5% (CDC).
- Percentage of 2019 Reported Abortions by Age of Mother (CDC):

- Women living with a partner to whom they are not married account for 25% of abortions but only about 10% of women in the population (NAF).
- In 2019, women who had not aborted in the past accounted for 58% of all abortions; women with one or two prior abortions accounted for 34%, and women with three or more prior abortions accounted for 8% (CDC).



At a gala Thursday night for an anti-abortion group, former Vice President Mike Pence took aim at sitting Vice President Kamala Harris over remarks she delivered at a pro-choice group's annual gala two nights earlier.

"I say with the lives of 62 million unborn boys and girls ended in abortion since 1973, generations of mothers enduring heartbreaking and loss that can last a lifetime: Madame Vice President, how dare *you*?" Pence told anti-abortion activists at the annual gala for Carolina Pregnancy Center in Spartanburg, S.C.

On Tuesday, Harris spoke at the Washington gala for EMILY's List, where she sharply criticized Republicans and conservative justices on the Supreme Court after it was revealed that the high court was poised to overturn Roe. v. Wade.



The Maryland senate will soon review a proposal to allow mothers to abort their baby a whole 4 weeks after it has left the womb.

After an abortion law took effect in Texas last fall that allows private citizens to sue someone who performs an abortion or helps someone obtain one after six weeks of pregnancy, Rabbi Mara Nathan, the senior rabbi at Temple Beth-El in San Antonio, knew she wanted to address it in a sermon.

"It definitely felt like a risky sermon to give," she said, "but I felt like I really didn't have a choice."

In the sermon, which she titled "The Right to Choose is a Jewish Value," Nathan took aim at the law, known as S.B. 8, and outlined how, as she put it, "Judaism has always been pro-choice."



Various streams of Judaism interpret Jewish law differently. Reform Judaism, of which Nathan is an adherent, supports abortion rights.

In response to her sermon, Nathan received a standing ovation, she said, along with angry reactions from "a few people who were upset" that she addressed abortion access from
