## THE FACT IS:

1. A BABY IN A WOMAN'S WOMB IS NOT HER BODY.
2. LADIES DON'T GET UPSET, BUT:
  - - WHEN YOU GET PREGNANT, YOU ARE TECHNICALLY INCUBATORS.

## WHY IT'S NOT YOUR BODY:

- #1. IT'S ONLY 1/2 YOURS (23 CHROMOSOMES)  
> THE OTHER 1/2 (23 CHROMOSOMES) CAME FROM A MAN.

IT'S AS MUCH THE MAN'S BODY AS IT IS THE WOMAN'S.



\*\*\*\* BTW: A WOMAN IS NOT A 'MENSTRUATING PERSON' AS DEFINED BY THE GOVERNOR OF MICHIGAN.

> A WOMAN / FEMALE IS A HUMAN BEING WHO HAS THE ORGANS TO PRODUCE 1/2 OF A HUMAN BEING (AN EGG) AND GESTATE THE OFFSPRING.

> A MAN / MALE IS A HUMAN BEING WHO HAS THE ORGANS TO IMPLANT 1/2 OF A HUMAN BEING (SPERM) INTO THE FEMALE SO THE SO THE OFFSPRING CAN BE FORMED AND GESTATED.

## WHY IT'S NOT YOUR BODY:

#2. ONCE FULLY GESTATED, IT CAN EXIST ON IT'S OWN, SEPARATE FROM YOUR BODY.

> NO PART OF A PERSON'S BODY CAN DO THAT.



## WHY IT'S NOT YOUR BODY:

- #3. ONCE THE BABY IS FORMED, THE WOMAN IS AN INCUBATOR.
- > SURROGATE MOTHERS CAN CARRY A FETUS, AND IT IS NEVER CONSIDERED TO BE HER BODY - BECAUSE IT ISN'T.
- > THAT FETUS IS NOT HER BODY. IT'S A SEPARATE HUMAN BEING IN HER BODY.

SINCE IT'S NOT YOUR BODY -  
REMOVING IT AND DESTROYING  
IT IS MURDER. IT'S KILLING AN  
INNOCENT PERSON.

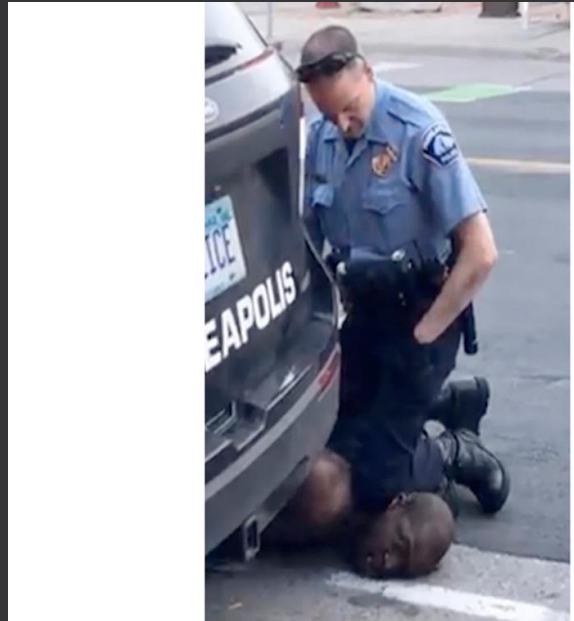
WHAT GIVES ME THE RIGHT TO INTERFERE WITH

- A. IF MURDER, OR KILLING AN INNOCENT PERSON ISN'T WRONG.
  - 1. THEN I HAVE THE RIGHT TO KILL YOUR CHILDREN, YOUR WIFE, YOUR HUSBAND, ANYONE.
  - 2. I HAVE THE RIGHT TO KILL WHOMEVER I DESIRE.

# WHAT GIVES ME THE RIGHT TO INTERFERE WITH ABORTION?

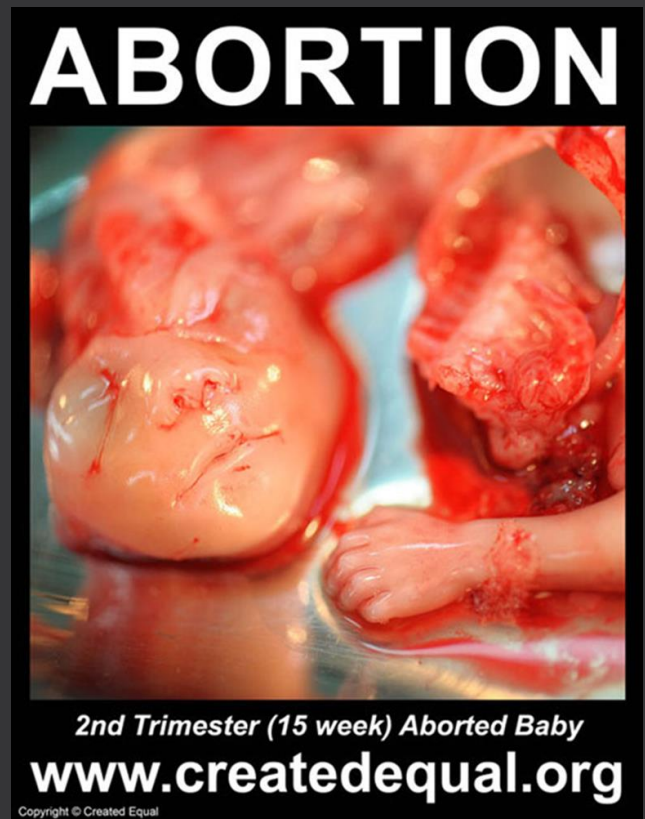
B. IF WE HAVE THE RIGHT TO STOP MURDERS, WE HAVE THE RIGHT TO STOP ABORTIONS. (IT'S MURDER)

If it's wrong to kill an innocent man: 'George Floyd' and the perpetrators must be held responsible.





Then it's wrong to kill an innocent baby that's still in the womb, and the perpetrators must be held responsible.



ABORTION IS A FORM OF BIRTH CONTROL.

1. BIRTH CONTROL, THAT DOESN'T INVOLVE MURDER, IS A SEPARATE ISSUE FROM ABORTION.  
(EXCEPTION: IUD)



ABORTION IS A FORM OF BIRTH CONTROL.

2. ABORTION BEING CLASSIFIED AS BIRTH CONTROL, IS NOT CORRECT.

> LIFE IS NOT BEING PREVENTED (BIRTH CONTROL)

> LIFE IS ALREADY HERE, IT'S BEING DESTROYED AND ENDED.  
(MURDER)

1) THE SANCTITY OF HUMAN LIFE IS THE BASIC BUILDING BLOCK OF HUMANITY.

- TO REMOVE IT, IS TO JEOPARDIZE THE HUMAN RACE.

- TO REMOVE IT ALLOWS ETHNIC CLEANSING AND PURGING.

(WE BECOME HITLER)

2) IF MURDER IS NORMALIZED IN ANY WAY,  
THEN EVENTUALLY EVIL  
PEOPLE WILL USE THAT NORMALIZATION TO  
KILL WHOMEVER THEY  
DESIRE.

> MY BODY, MY CHOICE: I CAN KILL ANYBODY  
WHO I THINK IS INFRINGING ON MY BODY BY  
TAKING AWAY MY FREEDOMS / CONVENIENCE  
/ MY CHOICES.
