Jacksonian Democratic Party was founded in the 1820s

Whig Party was founded in 1834 in opposition to Jacksonian Democrats

Settlers brought the national political beliefs and party affiliations of the Jacksonian Democrats and Whigs with them to this part of the Northwest Territory in the 1820s to 1850s.

As an extension of the national Jacksonian Democrats, the Democratic Party of Minnesota already existed when Minnesota became a territory in 1849.

The Whig Party was declining and the Republican Party was founded in Ripon, Wisconsin, on March 20, 1854.

The Republican Party of
Minnesota was founded on July
4, 1854, and held its first
convention on March 29-30,
1855, in St. Anthony,
Minnesota Territory.

In Minnesota,
political parties preceded
statehood, preceded our state
Constitution, and preceded state
statutes.

32nd state 1858 The organization and structure of Minnesota political parties existed for more than one hundred years and then it was memorialized in state statute in 1975.





CD8 Constitution: Article V, Section 1

"District conventions shall be held annually at the call of...the District Full Committee, and at such other times and for such other purposes as the committee calling the convention may determine. The place of holding the district conventions shall be determined by the District Full Committee."





Separation of CD Powers

"The management of the affairs of the party within the Eighth Congressional District shall be **vested** in the **District Full Committee** subject to the objectives of the Constitution and the direction of the District Convention."

Separation of CD Powers

"The Executive Committee shall administer and manage the party affairs within the district between meetings of the District Full Committee and shall make recommendations to the District Full Committee on questions or policy, appointments, and other matters."

CD8 Constitution: Article IV, Section 2

It is very easy to not practice what the Constitution establishes.

The Full Committee is vested with all the power and authority.

The EC is not vested.
