Standing Committees (6): Committee chairs must be board members. Board members, TPOA officers, and owners may serve on committees. The Board approves committee members and subcommittee members on standing committees. NOTE: Standing and non-standing committees may make recommendations to the board for actions or make budgetary recommendations but may not contract for nor commit TPOA to funding expenditures, Only the board, the president or the manager may do that.

1. **Architectural Committee**: Responsible for reviewing and approving any applications for new homes and additions such as fences, garages, storage sheds, or additions and modifications to existing buildings which would require a building permit.

2. **Grounds Committee**: Supervises and arranges for work parties and recommends to the board contracts with landscape firms to perform lawn care and landscape maintenance. Identifies hazardous and dead trees and recommends their removal to the board or manager for approval of the expenditures. The manager and president

arrange all contracts with contractors and hire outside contractors. Annual regular events: spring and fall cleanup days

3. **Facilities and Right of Way Committee**: Monitors condition of Association roads and recommends contracts for road paving and repair, streetlights, clubhouse and surrounding area and the storage unit. Acquires bids for repair work, etc. Includes the grounds around the clubhouse, playground maintenance, and tennis/pickleball court maintenance.
